

SMS Terms of Use

DEALER WIZARD TEXT MESSAGING TERMS OF USE

This agreement is between you and DEALER WIZARD or one of its affiliates. All references to “DEALER WIZARD”, “we”, “our”, or “us” refer to DEALER WIZARD.

“You”, “Your”, or “Yours” refer to you and/or your employees or agents.

By “Opting in” to or using a “Text Messaging Service” as defined below from DEALER WIZARD, you accept these Terms & Conditions.

I. DEFINITIONS

“Dealer Wizard” refers to Dealer Wizard, LLC. or one of its affiliates.

“Opting In”, “Opt-In” or “Opt In”, refer to consenting, enrolling in, joining, requesting, responding to, acknowledging, or otherwise agreeing to receive one or more text messages.

“Text Messaging Service” or “Texting Message Service” includes any arrangement where Dealer Wizard sends one or more messages addressed to your mobile or cellular phone number, the including text messages (e.g., SMS, MMS, or successor protocols or technologies).

II. CONSENT TO TEXT MESSAGING

III. DEALER WIZARD TEXT MESSAGING SERVICE PRIVACY POLICY

We respect your privacy. We only use information you provide through this service to transmit your mobile messages and respond to you. This includes, but isn't limited to, sharing information with platform providers, phone companies, and other vendors who assist us in the delivery of mobile messages. **This Text Message Service will be used for informational and business purposes and will not be used for marketing. In addition, mobile information will not be shared with third parties/affiliates for marketing/promotional purposes.** All the above categories exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties. Nonetheless, we reserve the right always to disclose any information necessary to satisfy any law, regulation or governmental request, to avoid liability, or to protect our rights or property. This Text Message Service Privacy Policy applies to your use of the Text

Message Service and isn't intended to modify our general Privacy Policy, incorporated by reference above, which may govern the relationship between you and us in other contexts.

IV. COST AND FREQUENCY OF TEXT MESSAGES

This Text Messaging Service is for conversational person-to-person communication between you and our employees. We may send you an initial message or a follow-up message providing details about the service. After that, the number of text messages you receive will vary depending on how you use our services and whether you take steps to generate more text messages from us (such as by sending a HELP request or responding to text messages).

We do not charge you for the messages you send and receive via this text message service. But message and data rates may apply, so depending on your plan with your wireless or other applicable provider, you may be charged by your carrier or other applicable provider.

V. E-SIGN DISCLOSURE AND OPTING OUT OF TEXT MESSAGES

By agreeing to receive text messages, you also consent to the use of an electronic record to document your agreement. You may withdraw your consent to the use of the electronic record by replying STOP.

If you no longer want to receive text messages, you may reply to any text message with STOP, QUIT, END, REVOKE, OPT OUT, CANCEL, or UNSUBSCRIBE. As a person-to-person communication service, opt-out requests are specific to each conversation between you and one of our employees and their associated phone number. After unsubscribing, we may send you confirmation of your opt-out via text message.
